# Hokkaido Tokubetsu Shienkin C

(Hokkaido Prefectural Government Special Support Subsidy)



## Outline

Since Aug., a new Hokkaido Tokubetsu Shienkin (Hokkaido Prefectural Government Special Support Subsidy) C will be provided for those who are not eligible for the cooperation support payment such as business closure and shortened business hours and national monthly support payment, as support for a wide range of businesses across Hokkaido, which have been in a very difficult business situation due to emergency measures.

## Requirement 1

### ① Businesses that have transactions with restaurants, etc. that were subject to shortened business hours requests

\* Suppliers of goods and services provided to the restaurant industry such as farmers and fishery operators, providers of food and drink, disposable chopsticks, hand towels, etc.

or

### ② Businesses affected by requests for refraining from going to and from other areas or going outside, etc.

\* Businesses affected by the reduction of the movement of people such as Japanese inns, souvenir shops, tourist facilities, taxi businesses, hairdressing and beauty-related businesses, various teaching establishments, shops, restaurants that operate during the day, etc.

## Requirement 2

**Sales in any month from Aug. to Oct. 2021 decreased by 30% to less than 50% compared to the same month of the previous year or the year before.**

\* **Special measures** are also implemented for those who cannot compare their sales with the previous year, such as new businesses.

\* If emergency measures are extended, the target month will be extended.

## Benefit Amount

Small & medium-sized enterprises: **200,000 yen**

Individual enterprises, etc.: **100,000 yen**

## Acceptance Period

**Oct 12, 2021 to Jan. 31, 2022**

Note 1: ① of requirement 1 is for **businesses that have direct or indirect transactions with restaurants, etc. that are subject to shortened business hours** (businesses subject to request for shortened business hours, business closure, etc. by the Governor of Hokkaido between Aug. to Oct. 2021).

Note 2: ② of requirement 1 is for **businesses whose sales have decreased as a result of the reduction of the movement of people due to the effects of requests for refraining from going to and from other areas or going outside in Hokkaido.**

Note 3: You can receive benefits from Hokkaido Tokubetsu Shienkin (Hokkaido Prefectural Government Special Support Subsidy) **C together with Hokkaido Tokubetsu Shienkin (Hokkaido Prefectural Government Special Support Subsidy) A and B.**

Note 4: **Restaurants etc. that are subject to the business closure or shortened business hours request** from Aug. to Oct. 2021 **are not eligible for this support**, regardless of whether or not they cooperate with the shortened business hours and receive the shortened business hours support.

Note 5: Hokkaido Tokubetsu Shienkin (Hokkaido Prefectural Government Special Support Subsidy) **C cannot be applied for by national monthly support payment (for Aug. to Oct.) recipients.** (Duplicate receipt is not possible.)

# Target Image of Hokkaido Tokubetsu Shienkin (Hokkaido Prefectural Government Special Support Subsidy)

★A separate one-time payment (“Hokkaido Tokubetsu Shienkin (Hokkaido Prefectural Government Special Support Subsidy) C”) will be added to the “Hokkaido Tokubetsu Shienkin (Hokkaido Prefectural Government Special Support Subsidy).”

Since Aug., a new “Hokkaido Tokubetsu Shienkin (Hokkaido Prefectural Government Special Support Subsidy) C” will be established and provided to those who are not eligible for the cooperation support payment such as for business closure and shortened business hours and national monthly support payments (a decrease of less than 30-50% compared to the same month of the previous year or the year before) as support for businesses in a wide range of industries that are affected by the Hokkaido Government’s requests accompanying priority measures to prevent the spread of disease and emergency measures.
